


DEED OF PARTNERSHIP

This instrument of partnership is made on this 30TH MAY, 2025 among

1) MR. GOHEL HARSHAL VIJAYBHAI
Resident of Rajkot, Block No.2, Pavan Appartment, Kishanpara-4/6 Corner, Rajkot.

2) MR. MALVI VAIBHAV MAHENDRABHAI
Resident of Rajkot, Alkapuri-1, Near Hanuman Madhi, Raiya Road, Rajkot.

Hereafter referred to as "PARTNERS" and which expression shall include their heirs, successors, executors, administrators and assignees;

Whereas the above partners have mutually agreed to carry on the business of Export Of Dehydrated Onion Products and Other Produce, the firm name "VH GLOBAL EXPORT" at Parjiya, 1-Alkapuri Plot No-15, Raiya Road, Rajkot as from 30/05/2025 in partnership and have commenced the said business accordingly from that date.

And whereas the partners are now desirous of reducing the terms of partnership in writing. Now, this agreement witnesses as follows;

1) **NAME OF PARTNERSHIP FIRM**

The name of the firm shall be "VH GLOBAL EXPORT" or any other name or names as the partners may mutually decide upon among themselves from time to time.

2) **ADDRESS OF FIRM**

The principle place of business shall be at, Parjiya , 1-Alkapuri Plot No-15, Raiya Road, Rajkot. And may be changed or shifted to other place or places by mutual understanding of partners.

3) **NATURE OF BUSINESS**

The business of partnership firm shall be that of Export Of Dehydrated Onion Products and Other Produce, and the same may be extended in such other line or lines as the partners may mutually agree upon from time to time.

4) **DATE OF COMMENCEMENT**

The partnership business has commenced and shall be deemed to have commenced with effect from 30/05/2025.

5) **CAPITAL AND INTEREST ON CAPITAL**

The Capital required for the partnership shall be contributed by each partner as per the commercial need and business requirements of the partnership from time to time and such capital shall be paid interest at the maximum rate (at present @ 12%) allowable under the provisions of the section 40(b) of the Income Tax Act-1961. Interest shall not be paid or paid at such lower rate as may be agreed between the partners, in case when the profits available before providing for such interest are insufficient. And any change in the provisions u/s. 40(b) of the Income Tax Act-1961 will be followed.

6) **REMUNERATION TO PARTNERS**

All the partners of the firm shall devote their time and attention to the management of the said business and they will be considered as "WORKING PARTNERS" of the firm. For this, they will be paid remuneration in the following ratio as per below 7 subject to maximum amount available of book profits according to the provisions of the section 40(b) of the Income Tax Act, 1961. The ratio can be changed as mutually agreed upon by the partners from time to time. The remuneration payable to working partners shall be credited to their respective accounts on ascertainment of book profits and the partners will be allowed to withdraw during the year.

7) **PROFIT/ LOSS SHARING RATIO**

The net profits or losses of the partnership business after payment of all expenses including interest on capital and remuneration paid to working partners shall be divided between the partners. All the partners will have share as under.

8) **ACCOUNTING YEAR**

The accounting year of partnership firm shall be from 1st April to 31st March unless changed by partners as mutually agreed.

9) **BANKING AND FINANCIAL TERMS**

The partnership firm may borrow, from time to time, from persons, firms, companies or banks or from any financial institutions as may be required for the purpose of the business as deposits or loans, at an agreed rate of interest. The bank account of partnership firm shall be with such bank or banks as the partners may from time to time agree upon and the same shall be operated by any partner.

10) **WITHDRAWALS**

Withdrawals by the partners shall be made as may be agreed upon, which shall be debited to their respective capital accounts

11) **OTHER BUSINESS**

No partner without the consent of the other partners shall enter into business of a speculative nature in the name of partnership, pawn, pledge or assign his interest or allow the same to be encumbered in any way for his personal debts.

12) RETIREMENT FROM FIRM

The partnership shall be "At Will" and in case any partner desires to retire from the said partnership, he shall be at liberty to do so by giving three months notice in writing to the other partners.

13) DUTIES OF PARTNERS

Each partner shall use his best skill and endeavor in the conduct, promotion and prosecution of the partnership business for the mutual advantage and benefit.

14) BOOKS OF ACCOUNTS

Proper books of accounts shall be maintained and all partners are entitled to inspect and take copies of such accounts

15) DEATH OF PARTNERS

On the death of a partner, the firm shall not be dissolved and legal heir or heirs of the deceased partner shall be taken as substitute of the deceased partner on the same conditions as herein provided.

16) SOLUTION OF DISPUTES

All the disputes and differences whatsoever which shall either during the partnership or after the termination thereof arise, between the partners or their representatives for any clause or clauses remain contained or any account, valuation, divisions, debts or liabilities etc. shall be referred to in accordance with the provisions of the Indian Arbitration Act, and the case shall be, binding on all the parties to the said disputes. Each partner shall be able to appoint arbitrator.

17) POWER OF PARTNERS

Notwithstanding anything stated or provided herein, the partners shall have full powers and discretion to modify, alter or vary the terms and conditions of the partnership deed in any manner whatsoever they think fit, by mutual agreement, which shall be reduced to writing and signed by all the partners and there upon the said writing shall become appendage and part of this deed.

In respect of the matter not specified or provided herein shall be governed by the provisions of the Indian Partnership Act, 1932.


