- 110 Company can join, merge, establish partnerships or new companies or enter new business fields with local and foreign companies that are already established or will be establish and have any kind of execution subject. Company can continue its business operations in its own name or directly in the name of third parties or by renting the services of third parties or by merging with the people in Turkey.

4. COMPANY HEADQUATERS

Company headquarters is in city of ISTANBUL, district of ŞİŞLİ. Address is 19 MAYIS MAH. HALASKARGAZİ CAD. ÇİFTKURT BLOK NO:226, İÇ KAPI NO:24 ŞİŞLİ / ISTANBUL. In case of address change, new address is registered to the trade registry and published in the Turkish Trade Registry Gazette. Any notifications made to the registered and published address is considered to be done to the company itself. For companies who have changed their address but did not register the new address within due date, this condition serves as reason for termination.

5. DURATION

The duration of the company is **infinite** as of foundation. This duration can be extended or shortened by means of changing the company agreement.

6. CAPITAL AND TYPE OF SHARE CERTIFICATES

Company capital is worth total of 999.000.000,00 Turkish Lira, consisting of xx shares, each with x Turkish Lira worth.

999.000.000,00 Turkish Lira corresponding to xx shares, each worth x Turkish Lira is stipulated by ŞEREF TUFAN in cash. Nominal values of cash stipulated capital will be paid within 24 months following the registry of the company.

7. COMPANY MANAGEMENT

Company procedures and operations are conducted by one or more managers appointed by general board. ŞEREF TUFAN with Turkish nationality and ID no: 593*****56, residing in ISTANBUL / BAHÇELİEVLER is appointed as Manager until further notice. Mode of Authorization: Authorized for individual representation

8. REPRESENTATION

Company is represented by the Managers. Signatures that would represent the company are determined, registered and published by the general board. Managers can appoint the ones who have service contract with the company as commercial deputy with limited authority or other trade assistants. The responsivities and authorizations of such appointed people are clearly stated in the prepared internal directive. In this condition, the registry and announcement of internal directive is mandatory. Commercial deputy and trade assistants cannot be appointed by inner directive. Authorized commercial deputies and other trade assistants are also registered and announced in the commercial registry. Managers are severally responsible for the damage caused by these people to the company and third parties.

9. GENERAL BOARD MEETINGS

General Boards are done on ordinary and extraordinary basis. Ordinary general board meeting is done yearly within the 3 months following the closure of accounting period whereas extraordinary board meetings are done whenever the Company business requires. In the general board, the voting right of each shareholder is determined based on nominal value of their principal capital share. General board meetings and quorum of the meetings are subject to Turkish Trade Law terms. General board meetings are done either in company headquarters or at a convenient place in the city where managing center is.

10. ANNOUNCEMENT

All company announcement, including general board meeting invitation are published in Turkish Trade Registry Gazette. Announcement related to the general board meetings are supposed to be published at least ten days prior to the meeting date.

11. ACCOUNTING PERIOD

Account period of the company starts of 1st day of January and ends on 31st day pf December. However, the first accounting year of the company starts at the official foundation date of the company and ends on the thirty first day of December.

12. PROFIT DETEMINATION AND DISTRIBUTION

The company net profit is the amount left after all paid expenses are deducted. Each year, 5% of the net profit for the period is allocated as reserve fund; remaining amount is distributed to share holders as per general board decision. Profit share is calculated in proportion to the total amount obtained by adding the achieved additional payment liability amount to the nominal value of the principal capital share.

13. RESERVE FUND

Turkish Trade Law, articles 519 and 523 are applied for reserve fund allocation.

14. LEGAL PROVISIONS

Turkish Trade Law provisions are applied for subjects not covered in this company agreement.
