Exporting with Wolf Thread

- i) Ready-Made Garments & Apparels: **\$0.25** per piece (commission may vary based on quality).
- ii) Fabrics: **\$0.25** per meter (further pricing details discussed per deal).
- iii) Raw Materials: Commission rate determined on a case-by-case basis.

First Deal Support

- i) Each company representative will participate in a Google Meet introduction with their assigned foreign importer to finalize details.
- ii) Our role is to facilitate the initial connection. Subsequent interactions are between you and the importer.
- iii) We only collect commission on the first deal facilitated through this program.

Building Trust

- i) We verify the legitimacy of both parties before connecting you.
- ii) We encourage open communication to ensure a smooth and safe transaction.

Delivery

- i) We don't interfere in the agreed-upon delivery process between you and the importer.
- ii) We require valid trade licenses and custom clearances for export.
- iii) In case of export challenges, we can connect you with our partnered exporters for assistance.

Our Commitment to You

- i) Wolf Thread stands by its promises. We may request legal documentation for verification purposes.
- ii) We seek transparent communication and accurate information.
- iii) We encourage companies to disclose relevant past deals for better understanding.
- iv) All exporters, regardless of experience, receive equal service and treatment.

Post-Ramadan Commission Update

Please note that commission rates will increase after Ramadan. Companies signing up during Ramadan will be grandfathered in at the current reduced rates.

- vi) Importers may request samples for verification purposes. Discuss sample costs and responsibilities with the importer upfront.

- i) Both parties will finalize a detailed contract outlining the agreement.
- ii) Importers may request samples to confirm quality. Discuss sample costs and responsibilities with the importer upfront.
