- 1. The Name of the company is: JMG REALTORS & INVESTMENT LTD
- 2. The Registered office of the company is situating in Nigeria.
- The object for which the company is established are:
 - To acquire land, buildings and real estate of any description including easements and other proprietary right(s) and to hold, improve, alter, develop, let, sell or otherwise dispose of the same. To carry on business, generally as dealers in landed property, property managers, general contractors, dealers, renovators, printers, suppliers and property developers, asset management and to employ the services of estate management and solicitors.
 - To acquire, lay, develop, hold and manage (without prejudice to the generality of the foregoing) residential estates, trading estates, ranches and farming estates and to deal in and dispose of the same in any desired manner. To construct and provide on any estate (whether or not owned by the company) any desirable works including rounds railways, canals and docks; and to maintain, manage, supervise and control the use of the paine.


