Ta Shuan Co., Ltd was established on 16 February 2005 under business license No. 0302187788 (9th update on 07 February 2024) at Lot 7-9-11, Road 1, Tan Tao Industrial Park, Tan Tao A Ward, Binh Tan District, Ho Chi Minh City, Vietnam. The facility is manufacturing household plastic items. The main production processes are below: Mold making, Plastic injection, Assembly, Inspection, Packing, input into finished product warehouse.

Audited location information: The total land area is 11,253 square meters, the facility has 3 main buildings as below:

- Building 01: 2,210 sqm with 1 mezzanine; 1F: occupied for Main office and production area: Assembly, Inspection, Packing and Finish good warehouse; Mezzanine: showroom area
- Building 02: 2,612.5 sqm, occupied for Plastic injection area and Raw material warehouse.
- Building 03: 2,210 sqm with 01 mezzanine; 1F: occupied for production office and mold making area; Mezzanine: Director room.
- * Remark: Beside that there are supporting facilities, including security guard rooms, waste storage rooms, air-compressor rooms.

Operating shifts and hours: Workers worked from Monday to Saturday. Rest days are fixed on every Sundays. The normal working time is 8 hours per day

- Office shift: 08:00 17:00 (break time from 12:00 to 13:00)
- Production shifts: 06:00-14:00 (break: 30 minutes); 14:00 22:00 (break: 30 minutes); 22:00 06:00 (Break: 45 minutes)
- Security team: 06:00-14:00 (break:30 minutes); 14:00 22:00 (break:30 minutes); 22:00 06:00 (Break: 45 minutes) No Peak season in 12 past months.

Time recording system: The biometric fingerprint equipment is equipped to monitor working hours done by the employees.

Salary payment details: Salary was paid on 25th and 10th of every month, the legal minimum wage applied to this facility was 4,680,000VND/month until 30 June 2024 and 4,960,000VND/month since 01 July 2024, the facility paid at least 5,200,000 VND/month until 30 June 2024 and 5,500,000 VND/month since 01 July 2024. Salary is paid by Cash with pay slips provided to the employees. If pay day is fallen into holidays or Sunday, wage is paid one day earlier.

Worker number information: There were 74 employees including 30 males and 44 females.

Good practices:

- 1. The facility have a strong internal social compliance to monitor compliance of all departments. There is strong commitment of management to comply with local law, amfori BSCI requirements.
- 2. The legal minimum wage applied to this facility was 4,680,000VND/month until 30 June 2024 and 4,960,000VND/month since 01 July 2024, the facility paid at least VND VND 5,200,000 per month until 30 June 2024 and 5,500,000 VND/month since 01 July 2024.

Worker organization details: Ta Shuan Co., Ltd has been established on 31 May 2023. The facility has established the Collective Bargaining Agreement and updated on 01 March 2024. There were the periodic meetings between workers, trade union representatives and management board.

Summary of findings: On 29 October 2024, the auditors conducted the closing meeting with the facility management and defined non-compliances in PA 1, PA 2, PA 7, PA 12 to the facility management and all non-compliances were agreed by the facility management.

Question: 1.1 Is there satisfactory evidence that the auditee has set up an effective management system to implement the amfori BSCI Code of Conduct?

It was noted that the management system was established and implemented by management board according to the amfori BSCI Code of Conduct. However, there was some non-compliance that need improvement in PA1, PA2, PA7, PA12. The management board documented Suppliers Control procedure and a list of approved supplier and contractors. Stationery, spare part of machine and security service suppliers were assessed for social performance. However, significant materials suppliers were not assessed for the social performance. During the facility tour and worker interviews, It was noted that the operation buttons, the emergency stop button and the warning sign of the plastic injection machine in the injection area were not labelled in local language. This is partial noncompliance.
