- 4- Denatured Ethanol

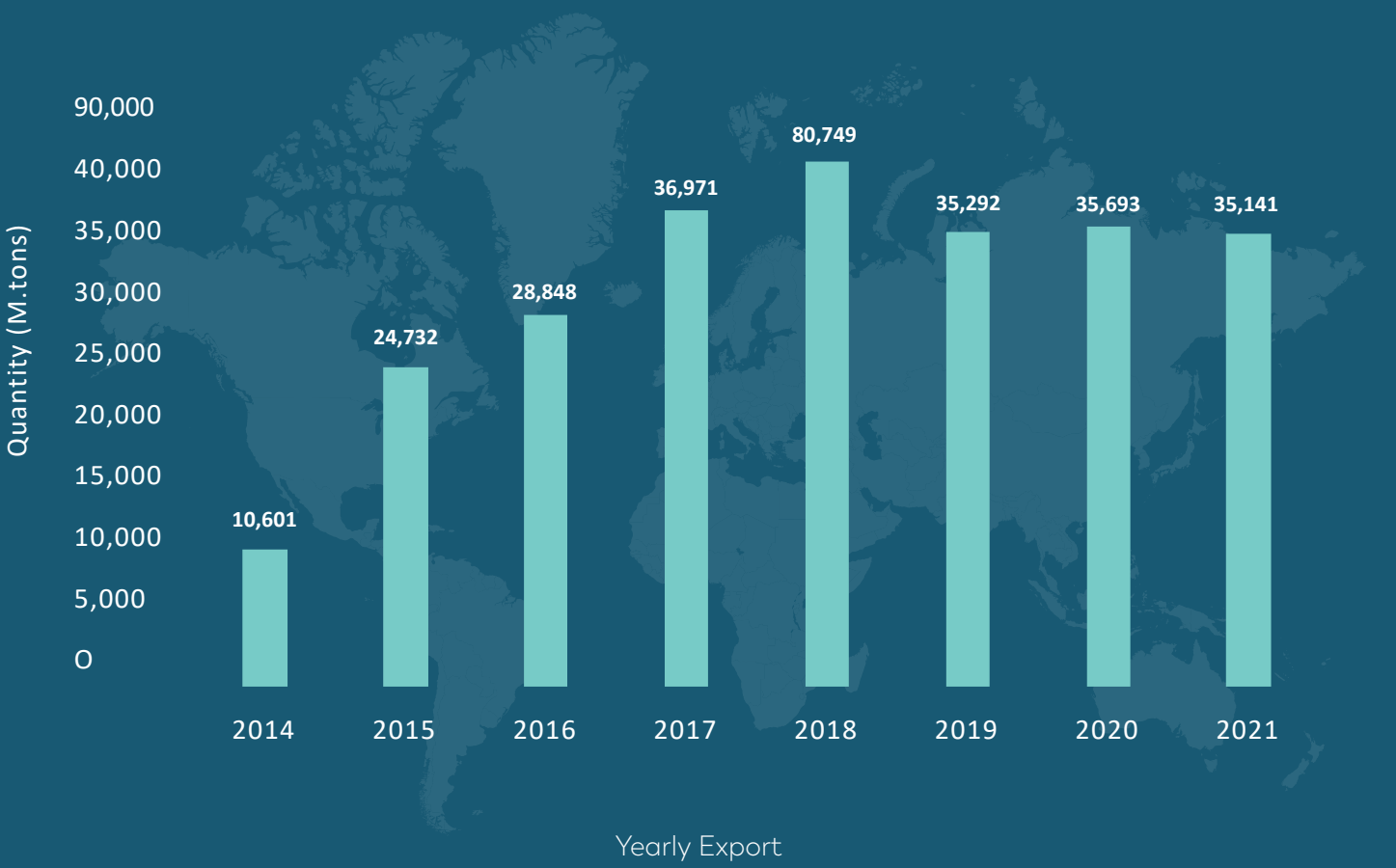
## USES OF OUR ETHANOL

## Bulk

We offer Ethanol in Bulk on FOB basis, which are loaded from our Shore tanks to the vessel. We have Dedicated Tanks at Durban Port, The quantity for one shipment is around 2000-5000 MT.



## ISO Containers

We also offer in ISO containers on FOB, CFR, and CIF basis. One 20' ISO can load approx 18.5 - 20 MT. Clean ISOs are available in stock in South Africa for prompt loading. South Africa also has an ISO Cleaning Facility of International Standard.

## FCL (Drums)

We also offer shipment in new HDPE Plastic (250 and 210 Litres) and Steel drums (210 L) and can load it in 20' or 40' dry container (FCL). We have Automatic filling machines to ensure exact Weight and customize labeling for each shipment

## MOLASSES

Our bulk of molasses procurement comes from our existing Two Sugar Units, This regular supply makes ensures the production of ethanol throughout the Year.

Sasol has the highest commitment to ensuring the best quality of molasses to produce ethanol. To maintain excellent product quality, we (Sasol) are in few producers who store molasses in steel tanks and have covered tanks with a total capacity of 105,000 MT.

## CO<sub>2</sub> PLANT

Sasol produces premium quality food-grade Carbon Dioxide gas of 99.99% purity level through sugarcane fermentation.

Carbon dioxide is a colorless, odorless & non-flammable gas that is vital to life on Earth, it is produced by liquid fermentation, burning of hydrocarbon with air, and as a by-product from chemical processes.

Sasol's Carbon Dioxide is used in products such as carbonated beverages, dry ice, casting molds, welding & metal fabrication. We have acquired CO<sub>2</sub> recovery technology from a renowned European vendor having annualized production capacity of 36,000 metric tonnes. Co<sub>2</sub> Plant is designed by Union Engineering, the leaders of food grade CO<sub>2</sub> process.

Quality Control (QC) is a vital component of our business and provides us an edge with our customers. At Sasol, we created a comprehensive Quality Control program that adopts a three-pronged approach encompassing our product, our customer, and our team.
