TITLE I
COMPANY NAME-OBJECTS-HEAD OFFICE-DURATION

Article 1: NAME

The name of the Company is CHEOREMI LOGISTICS SARL

Article 2: THE COMPANY SEAL AND COMPANY DOCUMENTS:

All documents, letters, invoices, announcements, publications and other company credentials emanating from the company shall carry the name of the company followed by the word (SARL) and the company logo.

Article 3: DOMICILE:

- g) Provision of services such as production of music and recreation.
- h) To enter into any or all lawful activities permitted under the Uniform Act which is incidental to the foregoing or necessary to accomplish the foregoing.
- i) To carry on any lawful business or activity, which may be conducted by a Private Limited Company, organized under the Uniform Act

Article 5: LIABILITY

- 1. The company shall not be liable for debts or other obligations of the shareholders;
- 2. No shareholders shall be responsible for the debts or other obligations of another;
- 3. No shareholder shall be liable for any debt or obligation of the company in excess of his subscribed shares.
